COUNTER AFFIDAVIT FILED ON BEHALF
OF 7TH and 8TH RESPONDENTS

I, Sriman Narayana Voora son of late Radhakrishna Murthy,
Hindu, aged about 61 years residing at No.47, B.N. Road (North Boag
Road), T.Nagar, Chennai-600 017. Tamil nadu, do hereby solemnly
affirm and sincerely state as follows:-

11. I submit that in view of the information narrated by her about the harassment and cruelty (mental torture) caused by the petitioner she had left my house without disclosing her whereabouts and I sincerely state that I am not aware of her whereabouts and I am not able to communicate with her.

12. I state from the Annexures filed particularly Annexure P-10 Colly dated 11.8.2007 refers to that in response to conversation with this respondent mentioned in E-mail in para 'I' or after. I submit that in one of the E-mail at Annexure P-10 Colly the petitioner addressed to Respondent No.7 that :-

“ I have been trying to reach Aditya for the past several weeks and Viji has completely cut me off from the life of Aditya. Mrs. Voora (Your wife) informs me that she does not know where Viji and Aditya are”

I submit that this respondent from September itself had no knowledge or awareness of the whereabouts of respondent No.6 and her minor child and that from ever since she left, he has no information at all about her whereabouts nor he had any contacts or connection with this respondent, and we are not able to trace her out and her minor child. In spite of knowing all these facts that these respondents are completely oblivious and in complete darkness about her whereabouts even on today, the petitioner is falsely alleging that these respondents are aware about respondent No. 6 and her minor child. Hence I submit that the above allegations are totally false and incorrect. The petitioner had even in the Synopsis narrated before this Hon'ble Court had at Page M stated “The Petitioner has been informed that the respondent No.6 is not staying at the Permanent address as mentioned by her and has illegally shifted the minor child to some unknown destination”.

16. In the circumstances stated above, I respectfully pray that this Hon'ble Court may be pleased to exonerate myself and my wife (Respondents 7 and 8 herein) from the array of parties and dismiss the petition as against both of us and thus render Justice.

That no new facts or grounds which have not been taken in the courts below have been taken in this Counter Affidavit.

I state that the contents of this Counter Affidavit are true and nothing material has been concealed therefrom.
